RE: Expenditure Statement Requirements

Please be advised that Education Law, Article 32, requires the filing of sworn statements by School Board Candidates with the School District Clerk and, for expenditures in excess of \$500, with the Commissioner of Education.

For expenditures that amount to less than \$500, a sworn statement indicating this to be the case must be filed with the School District Clerk only.

For expenditures in excess of \$500, a sworn statement with an attached list of the candidate's expenditures, as specified in section C on the statement form, must be filed with the Commissioner of Education.

These signed and notarized Expenditure Statements need to be filed on the following dates:

1. On or before the 30th day preceding the May 21st election or **April 22, 2019**;
2. On or before the 5th day preceding the election or **May 16, 2019**;
3. Within 20 days after the election or by **June 10, 2019**.
